

PUBLIC OFFER (TERMS OF SERVICE)

Last updated: April 2026

This Public Offer (hereinafter — the “Offer”) constitutes a legally binding agreement between the Service Provider and any individual (hereinafter — the “User”) who accesses or uses the website <https://boxofjoy.fun/> (hereinafter — the “Service”).

By using the Service, the User fully and unconditionally accepts this Offer.

1. Service Provider

The Service is provided by:

2. Description of the Service

The Service is an online platform that enables Users to:

- create gift campaigns (including monetary and non-monetary gifts such as messages, images, etc.),
- invite other participants via a shared link,
- collect funds and transfer them to a designated recipient.

The Service Provider acts solely as an **intermediary platform** facilitating the collection and transfer of gifts and is not a party to any transaction between Users.

3. Acceptance of the Offer

Use of the Service, including browsing, creating campaigns, or making contributions, constitutes full acceptance of this Offer.

If the User does not agree with these terms, they must discontinue use of the Service.

4. Payments and Fees

The Service uses third-party payment providers:

- **Payoneer** — for international payments (EUR/USD)
- **YooMoney** — for payments within the Russian Federation (RUB only)

Applicable fees:

- YooMoney: **+11%**
- Payoneer: **6%**

All fees are paid by the **contributor (donor)** and are displayed before payment confirmation.

The Service Provider is not responsible for additional fees, exchange rates, or charges imposed by payment providers.

5. Campaign Management and Refunds

Users may cancel a campaign at any time.

Refunds are possible only if:

- the funds have **not yet been transferred** to the recipient, and
- the request is made by the **campaign creator**.

If funds have already been transferred to the recipient, refunds are not possible.

6. Transfer of Funds

Funds are considered **delivered** when:

- confirmation is received from the payment provider, and
- the gift status changes to “Delivered”.

In the following cases:

- incorrect recipient details,
- recipient does not accept the gift,

the funds remain on an intermediate account and the campaign may be canceled.

Delivery delays may occur and are dependent on the payment provider.

7. Limitation of Liability

The Service Provider is not responsible for:

- the content of gifts (including messages, images, or any materials),
- relationships, disputes, or agreements between Users,
- actions or omissions of payment providers.

The Service is provided “as is” without warranties of uninterrupted or error-free operation.

8. Prohibited Use

Users agree not to use the Service for:

- fraudulent activities,
- money laundering,
- illegal fundraising or transactions.

The Service Provider reserves the right to suspend or terminate access, block campaigns, or refuse service at its sole discretion in case of suspected violations.

9. Privacy

10. Jurisdiction

This Offer is governed by the laws of:

- the Russian Federation, and
- the Republic of Serbia.

Any disputes shall be resolved in accordance with applicable laws of these jurisdictions.
